- **XVII.** Prepare for environmental and health and safety emergencies through open communication of our risks.

XVIII. Promote waste management based on the principles of reduction, recycling and reuse.

- **XIX.** Optimize energy, raw materials and water consumption through the research and development of increasingly advanced technological processes and the use of renewable energy, recyclable and/or reusable materials.
- **XX.** Prepare the assessment of the business context, including the nature, size, significant variations of processes and/or plants, due to the environmental impact and the protection of the health and safety of workers.
- **XXI.** Share with workers the company's objectives related to quality, environmental management and safety at work.
- **XXII.** Make the policy available to internal and external stakeholders, as well as review it periodically to ensure that it remains relevant and appropriate to the organization.
